

## **MOCDUPE Submission**

This is a redacted copy of a submission made and accepted by the Court.

The matter was referred to the local law enforcement on Friday 19 May 2023 by order of the Court.

Unfortunately it resulted in the untimely death of the alleged offender.

The names addresses and some dates were changed in order that the child and family involved can not be identified.

The Court also suggested that "Old Man" should "refine the document with the help of other clinical, legal and law enforcement professionals and publish it".

# **Submission by Old Man**

(As requested by the Court)

---

## **Abstract**

**When the term "Parental Alienation" is alleged, the matter should be referred to the law enforcement authorities as an offence occurred. Either the person alleging it is guilty of making a false report of child abuse, or the alleged perpetrator is guilty of MOCDUPE (Multiple Offences Committed During Unjustified Parental Estrangement).**

In this submission, I am referring to the Republic of Ireland enactments. Similar laws do exist in most jurisdictions.

Due to the complexity and multifaceted nature of Parental Alienation and the misinformation regarding the subject, the offending side is rarely recognised, investigated and acted on.

In this submission, I briefly explain several alleged offences against the child and the target parent, that should be investigated and, if proven, prosecuted.

# The Order of the Court received

On 6 March 2023, I received a note asking for an essay describing Parental Alienation as an offence, according to my understanding.

Google translate of the Court Order:

*The Court hereby makes an order that the Applicant approach "Old Man" or any other parental alienation person for an essay based on an affidavit describing parental alienation in plain language as a crime, specifically as child abuse. The essay may not copy and paste pieces by other famous people such as Gardener, Baker, Hartman, Bernet, Childress, O'Sullivan or others, but may refer to them. I'm not looking for a book, preferably less than a thousand words. The fact that parental alienation is not addressed in the DSM and IDC should be explained in addition. The essay should be reviewed by one or more parental alienation experts. A copy of the essay must be served on the respondent to allow him to refute any part of it. The return date is 15 May.*

Due to time restraints, the submission was only reviewed by one person. The review was positive.

Unfortunately this submission exceeds the 1000 word limit as suggested. I pray that the Court will understand the complexity and still accept it.

## Introduction

During the alienating process, several clearly defined offences are usually committed by the alienating party or parties. I listed clearly enacted offences according to Irish law in the attached document "Parental Alienation: Possible offences". (Downloadable at <http://oupajoe.ie/pa/Completed/Alienation%20offences%20v11.pdf>)

Although the MOCDUPE offences are listed in said document, it is not recognised as such. An explanation follows in this submission.

Much of the terminology used may be new to the reader. Please refer to the attached document "Parental Alienation Terminology". (Downloadable at <http://oupajoe.ie/pa/Completed/Alienation%20Terminology.html>)

As I am not a medical professional, I did not elaborate on the medical aspects mentioned. If this submission results in a criminal investigation, the police investigating officer will have to obtain confirming witness statements from the relevant local medical professionals.

I suggest that the reader do a web search on the relevant aspects mentioned to get a basic understanding.

# Basic facts

## General

I understand and believe that -

1. Parental alienation strategies are actions. It is not a psychological or psychiatric illness. The perpetrator usually suffers from one or more conditions. As in the case of other offences e.g. theft or murder, the strategies are not listed in DSM and IDC.
2. The physical and psychological effects and outcomes on the victims of the offences are listed in DSM and IDC.
3. Alienation strategies are not lawful sanctions.
4. The child and the target parent(s) are victims.
5. The effects and outcomes of the alienation strategies do have stress-induced physical and psychological effects on the victims.
6. Alienation strategies cause Adverse Childhood Experiences (ACEs) for the child.
7. Alienation strategies at an early age causes Early Life Stress (ELS) for the child.
8. Unjustified enforced estrangement is alienation.

## The Child: Medical

I understand and believe that -

1. BDNF (Brain-Derived Neurotrophic Factor) is a secreted protein that regulates many aspects of neuronal development and function in the nervous system. BDNF regulates neural stem cell survival and differentiation, axon/dendrite differentiation, synapse formation and maturation, and refinement of developing circuits. It is also a key regulator of synaptic plasticity and late-phase long-term potentiation.
2. Inhibiting the secretion of BDNF negatively affects stem cell survival and development and can be compared to inhibiting the intake of other proteins, vitamins and minerals that is essential for the child's development.
3. ACEs and ELS Inhibit the secretion of BDNF.
4. Alienation strategies cause negative neuroplasticity – Brainwashing.
5. Causing negative neuroplasticity is emotional abuse with long-term consequences as documented in DSM and IDC.
6. Limiting the secretion of BDNF affects positive neuroplasticity.
7. Affecting positive neuroplasticity endangers the child in developing lifelong conditions including early or even childhood Alzheimer's disease.
8. Affecting positive neuroplasticity is causing serious harm.

9. Affecting positive neuroplasticity causes stress-related diseases.

## Offences

At this stage, I am only giving my opinion on some of the offences against the child.

1. Reckless endangerment of the child -
  - a) Negative neuroplasticity affecting decision making
  - b) Stress related psychological and psychiatric conditions developing
  - c) Risks of other injuries
2. Causing serious harm – by affecting a body part (nervous system and the brain)
3. Cruelty to children -
  - a) Procuring the abandonment of the child (by the target parent)
  - b) Ill treatment by depriving the child of an essential nutrient that can only be produced by the body (BDNF).
  - c) Ill treatment by coercion
  - d) Verbal assault
  - e) Expose the child to situations not suitable to the child

## Concluding suggestions:

I suggest that the Court consider the following:

1. Appointing a clinical and/or law enforcement PAP (Parental Alienation Professional) to assess the matter using the recognised “Five Factor Model” and other relevant toolsets.
2. If the PAP confirms parental alienation, he/she should supply the Court with its findings outlining in detail -
  - a) the alienating strategies confirmed, using the “Beyond the High Road: 17 Parental Alienation Strategies” and
  - b) the level of alienation as mild, moderate or severe and
  - c) the level of access or parenting time at this stage.
3. If the PAP confirms parental alienation the relevant MOCDUPE and other offences should be reported to the relevant authorities for addressing and possible prosecution.
4. If the PAP confirms severe parental alienation, a custody change together with a 90-day no-contact Order should be made.
5. If the PAP suspect it to be justified estrangement, the relevant authorities should be notified and action should be initiated.

6. If the allegation of parental alienation is confirmed as unfounded, the relevant authorities should be notified and prosecution should be initiated against the Applicant.
